Black: those names in black voted to fast track the Trans Pacific Partnership (TPP), a terrible trade deal that will offshore even more jobs than NAFTA and open our local, state, and federal government to liability whenever our laws stand in the way of corporations making a profit with the Investor State Dispute Settlement process, whereby settlements are paid by taxpayers. Anyone with a phone number on this list needs to be called to demand a NO vote on the Trans Pacific Partnership. Green: those names in green didn't vote to fast track the TPP, but voted for the DARK Act, a bill making it hard to know for sure if our food contains genetically engineered ingredients.

GMO listed by their name, they voted for the DARK Act aka S 764, the Roberts-Stabenow Bill.
